5. Treasurers Report reviewed and explained by Don Leonard. Motion to accept as read by Ralph McIlroy and seconded by Steve Glass. Motion passed.
6. Membership Report by Ralph McIlroy:

 - i. Captain: Gary Springstroh

 - iii. Coaches, Manager: to be determined.
 - iv. Commitment fee was due Oct. 31—only 3 fees have been paid (Steve Glass, John Beard and Paula Murphy). This must be paid as soon as possible.

- d. State Team by Dorothy Filley
 - i. Contracts for 2010 Regionals: TDLS and CDA--signed and turned in today. Review contract and outcomes of this year. Will encourage fund raising possibilities such as board sponsorships.
 - ii. Atlanta Darts-poor response, change in ownership and reduced amount of supplies. They did not meet the agreed to financial obligations. There was a discussion of renegotiating with them about next year and include the tournament directors of SCDA and BCDA to speak from a strong front. There is a possibility of approaching a different supplier.
 - iii. Hotel Issues
 - 1. Will review existing contracts and bring them up to date with changes

- iv. Difference between Regional and Finals Food and Beverage sales.
 - v. Discussion of the problem of bring alcohol into the hall including the additional cost of door keepers/bouncers, Problem of officers and captains with alcohol brought into hall as poor example to team members. The loss of F & B sales at the Finals resulted in paying \$944.15 deficit. If this problem is not addressed by us--it will be by the hotel and will result in higher prices next year and possibly paying for the extra people at the door. The proposal of using our own people to help staff the doors and police the room will be further discussed at the next meeting.

 - i. Flier on website and will be emailed to officers and reps this week
 - ii. Raffle prizes--each association to bring a prize/donation
 - iii. Help--run tournament, sell raffle tickets
